From their founding in 1922 by Father John Joseph Sigstein, Our Lady of Victory Missionary Sisters have been dedicated to living the mission of Jesus. They proclaim the Word of God, foster justice, stand in solidarity with those living in poverty and/or oppression, and promote the development of leaders. The John Joseph Sigstein Foundation has been created to offer grants to organizations that will extend this approach to mission.

Mission Statement

John Joseph Sigstein Foundation (JJSF) is established to promote and sustain the mission of God according to the charism of Our Lady of Victory Missionary Sisters in solidarity with all persons, especially those living in poverty and/or oppression.

Grant Eligibility

The Foundation will consider requests for programs that promote justice for those living in poverty and/or oppression, empower persons to contribute to a more just and peaceful society, contribute to the well-being of the family, and protect and sustain the environment – God's creation. Catechetical formation programs will also be considered.

The Foundation is looking for programs that offer systemic change and will commit support on an annual basis only. Additional support would be contingent upon program performance and re-application for funds.

Grant applications will not be accepted for building projects, medical programs, political activities, elimination of deficits, individuals, scholarships, foreign organizations, projects already completed, or organizations that are already well-funded.

The John Joseph Sigstein Foundation shares the values of its sponsor, Our Lady of Victory Missionary Sisters.

Each application that is received will be judged on its own merits in conjunction with other applications submitted during the grant cycle. The granting of awards is subject to the resource limitations of the Foundation and the discretion of the board.

Applicants should be not-for-profit entities classified as 501(c)3, or equivalent status, by the Internal Revenue Service.
